# Benchmark Workshops for 2013

This document lists the benchmarks that ACOM decided on for 2013. Some changes may appear, but these are Unless ACOM comments otherwise, the Secretariat will progress along these lines. Attached is the 2012 list of benchmarks and stocks for information.

Benchmark workshops aim to describe the most relevant assessment methodology, and conist of a data compilation and an assessment methodological part (one 8 day meeting, or a 3 day preparation with a 5 day meeting around 3 months later). Input from stakeholders is welcome to improve the knowledge on the stocks and fisheries. Please mind that any new datasets should be made available 3-6 months before the meeting.

#### 2013

The stocks listed in the final table were identified by the Expert groups as candidates to be benchmarked in 2013. The subdivision of stocks into groups is based on similar issues between stocks. An alternative proposal is put forward because there are indeed different options of grouping the different stocks. EG members and WGCHAIRS will be asked to comment on the proposed subdivision.

ACOM decided on the stocks up for 2013 benchmarks in November 2011. Preparation of the meetings will start in the first half of 2012. A final decision on the 2013 benchmarks subdivision will be taken after the WGCHAIRS meeting in 2012. This includes considerations on undertaking a Baltic multi-species benchmark instead of separate benchmarks for the main species that are interrelated in the Baltid: cod, sprat and central herring.

In addition two workshops will take place in 2012, which may come up with results in 2012 already (in which case external reviews will be arranged afterwards, before the assessment EG).

- WKFLABA: The ICES/HELCOM Workshop on Flatfish in the Baltic Sea (first meeting 2010) prepares for a benchmark of the Baltic flatfish stocks in 2013.
- WKPESTO: The Workshop on the Evaluation of Plaice Stocks is the result of recommendations from WKFLAT 2010, 2011 and WGNSSK. The linkage between plaice stocks in the North Sea and adjacent areas will be discussed and the use of combined or disaggregated assessments of current defined stocks is to be explored.
