### Goal of the NWWRAC as organisation

Contribute to the achievement of the objectives of the CFP and in particular to advise the Commission on matters of fisheries management in respect of the North Western Waters.

This advice will incorporate the social, economic and environmental dimensions of fisheries as well as the Ecosystem Based Approach and Precautionary Approach to management and will be prepared with the general aim of attaining sustainable fisheries management.

# CO-DECISION PROCEDURE: "TRILOGUE" BETWEEN EU INSTITUTIONS (COMMISSION-COUNCIL-EP)

- •The Advisory Councils (ACs) are expected to have an <u>strengthened consultative role</u> to provide evidence-based advice in:
  - a. Multispecies/Mixed fisheries management plans
  - b. Technical measures
- Model or regional structure to be agreed in 2013





# Principal Barriers ("Weaknesses")

- Uncertainty in scientific assessments –
   ICES Methodology on Multispecies perspective
- 2. Micromanagement Regulatory framework over prescriptive RBM Decentralisation FDF Self Reg.
- 3. Need for simulations of management scenarios and (socio) economic IA in the short, medium and long term
- 4. FSP and initiatives to improve knowledge of stocks Annual report submitted to ICES
- 5. Analysis of the problem of mixed fisheries (discards) and technical interactions between national fleets

### Main output to date

The NWWRAC adopted in March 2011 an operational framework to develop a MAMP for the Celtic Sea. This plan was subsequently updated in Nov 2011.

- Description of management toolbox

# Biological (transitional) objectives for the Celtic Sea (VIIfg)

- 1. Achieve a common understanding of state stocks
- Concentrate on key commercial species looking at interactions with stocks with wider distribution area
- 3. Put a discards reduction programme in place
- 4. Follow scientific advice for MSY transition catch options by 2015 / avail of alternative approach
- Work with scientists to redress data deficiencies
- 6. Work with ICES to integrate fishermen's data in scientific assessments (data compilation and WK)
- 7. Develop a suite of indicators and risk assessment framework for "by-catch" species
- 8. Identify vulnerable species and habitats impacted

# Economic (transitional) objectives for the Celtic Sea (VIIfg)

- 1. Ensure a viable fleet
- 2. Optimise the economic return to the fishing industry
- 3. Prevent the expansion of effort in the area through capacity limitation, i.e. manage fleet structure
- 4. Develop co-management framework (RBM...)
- 5. Promote efficiencies and reduce carbon footprint
- 6. Develop an economic model and performance indicators for the fishery

# Social (transitional) objectives for the Celtic Sea (VIIfg)

- Define an appropriate set of social criteria relevant to mixed demersal fisheries in the CS
- 2. Define the parameters to be measured based on 1
- Engage the fishing industry and other stakeholders in defining 1 and 2, and also on data collection, assessment and management process
- 4. Adopt effective measures to strengthen resilience of the vulnerable fishing dependent coastal communities
- 5. Develop a social model and performance indicators

### Latest Developments - Chronology

- \* April 2012: Coordination meeting NWWRAC-DG MARE
- \* May-June 2012: Steering Group led by Norman Graham presented a ToR for a Study to develop a bio-economic model that might serve as decision support tool to assess management options and evaluate trade-offs
- \* <u>July-September 2012</u>: The DG MARE informed on progress on the possibility of launching a study
- \* January 2013: Publication of a call for tenders MARE/2012/22 LOT 1 Scientific support for the development of a management plan in the Celtic Sea
