1. Introduction

The North Western Waters Regional Advisory Council (NWWWRAC) was established in accordance with Commission Decision 2005/668/EC on the 22nd of September 2005 as one of the seven Regional Advisory Councils, proposed under Council Decision 2004/585/EC, establishing Regional Advisory Councils under the Common Fisheries Policy.

In its sixth year of operation, which runs from October 2010 to September 2011, the NWWWRAC wishes to apply for grant-aid from the EU Commission, in accordance with stipulations set out in Council Decision 2004/585/EC, as amended by Council Decision of 2007/409/EC.

2. Objectives of the North Western Waters RAC

The principal aim of the RACs is to bring together European stakeholders, including fishermen, the representatives of producer organisations, environmentalists, recreational anglers, processors, consumers and women's networks, amongst others, to provide evidence-based advice to the EU Commission, Member States and the European Parliament on matters of fisheries management within the geographical limits of its remit (i.e. the community waters of areas Vb, VI and VII).

The proposal, presented by the NWWWRAC, aims to achieve the sustainable, biological and economic management of fish stocks, within the geographical remit of the north western waters RAC, in compliance with the objectives of the Common Fisheries Policy.

It is also within the scope of the proposal to address the sustainable, biological and economic management of fish stocks in the wider context of an integrated maritime policy.

Given the mixed nature of the fisheries within the geographical remit of the NWWWRAC, an ecosystem-based approach will provide the foundation for advice, which will contribute to the achievement of good environmental status of the marine environment, as articulated in the Marine Strategy Framework Directive.



3. General Work Programme: Main Areas of Work

The work programme of the NWWRAC (2010/2011) will address the following issues:

3.1. Reform of the CFP

In October 2010, the NWWRAC will convene a scoping meeting on governance and regionalisation [of the RACS under the reformed CFP], gathering all information produced to date, in order to inform discussions on this matter.

The NWWRAC will prioritise this area over the first quarter of year 6 (October-December 2010) in order to submit an opinion before the Commission releases the regulatory proposal regarding this issue.

The NWWRAC will also work in conjunction with other RACs, to bring proposals on other topics of common interest (e.g. capacity, allocation of fishing rights, technical measures, definition of fleets, socio-economics, etc.) to the attention of the Commission.

3.2. Development and implementation of long term management plans for fish stocks in North Western Waters

The Development and implementation of long term management plans for fish stocks in North Western Waters is the main work priority for 2010/2011 (Year 6).

Initially, the NWWRAC will establish a clear set of objectives in order to develop a long-term management plan for the demersal fisheries of the Celtic Sea.

This will be achieved by the implementation of a pragmatic and stepwise approach that takes into consideration environmental, biological, economic and social factors. The process will be agreed and validated by scientists, control authorities and relevant experts, before being presented to the Commission.



The NWWWRAC will also address inputs to long-term management plans for other species in the following manner:

Northern hake:

The NWWWRAC will continue to work with ICES, STECF and the South Western Waters RAC, to produce evidence-based recommendations and opinions, in response to discussion papers and regulatory proposals from the Commission.

Haddock (West of Scotland):

The NWWWRAC will continue to work closely with ICES to develop a proposal for the implementation of a long-term management plan, as requested by the Commission. Further work will be subject to the results of the socio-economic impact assessment being made available and a formal proposal from the Commission being provided to the RAC for comment.

The NWWWRAC will also address:

- The most appropriate management measures on the review of a LTMP for Sole in the Western Channel;
- Proposing measures for the management of Nephrops in area VII; and
- Developing practical and functional opinions for the management of Irish Sea stocks.

3.3. Fishing Opportunities and the improvement of the quality of scientific and economic data for 2011 and 2012

The NWWWRAC is committed to improving professional networks and strengthening relationships with scientists (i.e. National Institutes and ICES), representatives of Member States and the Commission.

3.3.1. Regional Task Force

In conjunction with specific professional support, the NWWWRAC will establish a regional task force whose remit will be to improve the quality of data and to mitigate uncertainty in the knowledge of stocks in the medium-term.



The Regional Task Force will:

- Assess the quality of existing data, available in national and European sources;
 - As a priority for Year 6, the NWWRAC will seek to enhance collaboration with ICES scientists to identify useful data that can be used for key stocks, that are planned to be benchmarked in 2011 and 2012 (e.g. V1a anglerfish, cod, megrim).
- Identify data deficiencies in the evaluation process; and
- Provide reliable and valid data from the fishing industry that can be input into scientific assessment.

3.3.2. Annual allocation of resources (TAC and quotas) and related management measures

A large part of the first quarter of Year 6 (2010/2011) will be dedicated to the production of professional advice for the Commission on the annual allocation of resources (TAC and quotas) and related management measures (e.g. effort regime) for demersal species.

Within the third quarter of Year 6 (2010/2011), the NWWRAC will provide the Commission with its opinion on the proposals for Fishing Opportunities for 2012, with special emphasis placed on the principles upon which the Fishing Opportunities are structured, the range and timing of achievement of MSY values and the rules referring to stock status categories used to determine the TACs.

Following a specific request from the Commission, the NWWRAC will provide further advice on access regimes and fishing opportunities for deep sea species in 2011-2012 during Year 6 (2010/2011).

3.4. Marine Protected Areas and Marine Spatial Planning

The NWWRAC will continue to be involved in the identification of sites of fishing activity and/or the development of management plans for different types of protected areas (e.g. MPA, MCZ, SAC) in North Western waters that are to be adopted under both national and Community legislation. A particular insight will be given to the ongoing consultation being carried out in United Kingdom and France.



In this respect, the NWWRAC will re-convene the Horizontal Working Group on Marine Spatial Planning, led by eNGOs representatives of the NWWRAC (Chairman and rapporteur), with a wide representation of experts including those from appropriate, EU projects (e.g. MEFEP0 and CHARM III in 2009/2010).

The NWWRAC has overcome past difficulties in the exchange of information with national institutes and intends to work, in Year 6, with the designated agencies from the Member States and the Commission in the following manner:

- Participate in national debates and occasional stakeholders' forums;
- Organize follow-up meetings and invite relevant experts to communicate current status reports and present timetables for consultations, where relevant;
- Circulate newsletters, maps and questionnaires provided by consultants to stakeholders and provide feedback.

3.5. Technical Conservation Measures and Discards Policy

Since its creation, the NWWRAC has dedicated a considerable amount of time and effort addressing the critical areas of Technical Conservation Measures and the development of policy regarding discards.

Given the importance of these issues, the NWWRAC will continue to work on these areas if required by the Commission.

3.5.1. Technical Conservation Measures

The NWWRAC will address TCMs if there is any development of legislative proposals on the subject in North Western Waters and will provide the Commission with timely, professional opinion, where necessary.

Given the complexity of the issues involved and the regional specificities of each fishery, the NWWRAC requires a reasonable period for consultation (i.e. at least three months) from the Commission. It is also essential that proposed measures for consultation are made available, by the Commission, in all the working languages of the RAC, in order that the membership may adequately prepare their professional opinion.



3.5.2. Discards Policy

The NWWRAC plans to hold Working Group discussions to consider discarding in area VII in certain fisheries and the effects of mitigating measures.

This NWWRAC will address this issue in the first half of 2011, depending on the work priorities of the NWWRAC and additions to the work programme emanating from the Commission.

3.6. Other topics of interest

The Executive Committee of the NWWRAC will instruct working groups to address specific topics for discussion, as considered necessary and appropriate, throughout the course of the year and dependent on the availability of existing resources.

3.7. Working procedures

The NWWRAC will continue to refine working procedures to ensure efficient and effective work practices.

The NWWRAC will work closely with other relevant RACs, the industry, NGO representatives, scientists and the Commission to develop appropriate work programmes to progress issues of common and specific concern.

3.7.1. Timetable

- Annex I details the timetable for discussion of key issues within the NWWRAC;
- Annex II details issues of specific interest that the Commission has proposed for the 4th quarter of 2010, which are relevant to the NWWRAC and which require the professional opinion of the NWWRAC.



4. Operational Structure; Meeting types and frequency

The largest budgetary expenditure incurred by the NWWRAC is associated with meetings. The NWWRAC is liable for all costs associated with meeting room hire, interpretation services and technical equipment, in addition to the travel and accommodation costs of members and experts attending NWWRAC meetings.

In order to achieve the objectives of the work programme, the operational hierarchy of the NWWRAC is currently organised in the following, three-tier structure¹:

4.1. Executive Committee

All decisions, relating to the NWWRAC, are made by an Executive Committee (ExCom) of 24 members. Currently, there are 21 members on the Executive Committee and three vacant seats. Executive meetings are held at least three times a year and normally address high level policy issues, debating the recommendations of Working Groups and reaching consensus in the form of RAC advice and opinion.

Each member (plus the Chairman of each Working Group presenting the recommendations to the ExCom) is reimbursed for attending the meeting, and full interpretation is provided, in the three working languages of the NWWRAC (i.e. English, French and Spanish). Commission and EP representatives are also formally invited to attend.

4.2. Working Groups

Working Group meetings are held 2 to 3 times a year and are the main drivers of the NWWRAC. All issues necessary for debate are tabled at these meetings. A number of experts, as well as Commission members, are often invited to attend and make presentations at these meetings. There are currently 4 Working Groups in the NWWRAC, which are geographically based. Additional Horizontal, Working Groups are also convened, as required, to discuss issues, which are of common interest to all NWWRAC members (e.g. Marine Spatial Planning, CFP Reform). Working Group meetings are normally held over 2-3 days.

¹ Note: A review of the current operational structure is the subject of ongoing discussions within the NWWRAC.



Membership of Working Groups varies from 25 to 40 participants depending on the subject matter and full interpretation is provided (i.e. English, French and Spanish).

4.3. Focus Groups and Workshops

Focus Group meetings and Workshops are specialist meetings, which are convened as required when issues of urgent concern require an immediate response from the NWWRAC. These groups are formed from within the general membership and consist of a small group of members with specific professional experience and expertise.

Such meetings have a specific function and outcome requirement, such as the drafting of response papers (e.g. Nephrops Management Group); the development of a draft opinion with relevant experts (e.g. Celtic Sea Fisheries) or to form a NWWRAC opinion, by consensus, which is contentious or where there are divergent positions within a working group (e.g. Deep water Focus Group).

In order to incorporate the flexibility required to accommodate these meetings, the NWWRAC has budgeted for 5 Focus Group or Workshop meetings, with a maximum of 8 participants, in Year 6. Interpretation services for these meetings is assessed and provided as and when necessary and contributions-in-kind are sought from Member States to maximise cost efficiency.

5. Improved Communications and Transparency

The NWWRAC Communications Strategy aims to promote the work of the NWWRAC and improve public and professional awareness of RAC outputs and opinions. In Year 6, this will be achieved by improving transparency and the level of communication with all stakeholders by producing regular e-newsletters as well as press releases posted in the Press section of the NWWRAC website (i.e. www.nwwrac.org).

In addition, the Secretariat will maximize the functionality of the website so that members can continue to work between meetings using the interactive forum and meeting space options, which it has developed.



Recognising the important role of NGOs and other interest groups in the functional balance of the NWWRAC, the Secretariat will also continue to encourage new members to join this grouping and fill the vacant seats available.
