



Background

- ICES experts have developed a method to use UWTV surveys to assess and provide catch options for *Nephrops*
- The approach;
 - Absolute abundance estimates from surveys
 - Removal estimates based on sampling & discard survival rates
 - Stock Specific Harvest rates consistent with MSY
- The advice has been delayed until autumn to make use of summer surveys.
- Advice on landings and catches given for 2015




FU14 – Eastern Irish Sea








FU15 – Western Irish Sea

FU 15 : TV abundance








FU 15 : Harvest rate








FU 20 (Labadie) and FU 21 (Jones and Cockburn)








Data Deficiencies

- FU11-13, 15, 17 & 22 No major issues highlighted
- FU16 – Industry information critical
- FU20-21 Improvements in information base thanks to benchmark (especially FR- VMS data). Sampling intensity remains low
- FU19 Sampling coverage is problematic
- FU14 Sampling resumed in 2013 after a few years of insufficient sampling
