Focus Group Climate Change and Environment

Time frame and deadline:

12 months (June 2020 – June 2021) starting out as a task force with the possibility of extension and/or conversion into a standing group.

The Group will work mainly via virtual meetings and written electronic procedure, to minimize its carbon footprint. Face to face meetings will also be organised once or twice per year when required and possibly in correspondence with other NWWAC meetings.

The FG Climate Change and Environment will function within the Horizontal Working Group. Papers produced during the COVID-19 crisis will undergo a written procedure at the NWWAC ExCom for revision and adoption. An update on the commencement of this FG will be presented to the ExCom at the virtual NWWAC meetings in July. A report on the work and future planning of the FG will be presented at the NWWAC September 2020 meeting in Dublin.

Focus Group

By adopting the EU Green Deal in December 2019, the COM is putting climate and environmental action as one of its key priorities. In this context, several EU initiatives fostering climate change mitigation and adaptation and environmental protection will be implemented and need attention and involvement from the NWWAC.

As these are ongoing issues which will need attention over the coming years, this standing Focus Group on Climate Change and Environment will identify and examine the NWWAC needs in developing related advice.
