The [online questionnaire](#) follows the chapters of the CFP Regulation. It is part of the targeted stakeholder consultation, which will help the Commission collect information on the functioning of the CFP.

The questionnaire will provide the basis for more in-depth discussions at regional level starting in April 2022. The consultation process will end with an event before the summer of 2022. The report will also be based on the supporting studies, referred to in the corresponding chapters of the questionnaire.

Could you clarify when the preliminary outcomes/report on regionalisation of the CFP and climate change studies (1st on mitigation and adaptation and 2nd on post harvest activities) will be made available? They are under finalization, to be published in April. 2nd report on climate change to be published later at end of the summer. Possible to organize presentations on the study at future ACs meetings.
