Subject: Technical Conservation Framework Regulation for fisheries

Dear Mr Mato,

It is our understanding that the member states are making rapid progress towards a general position on the Commission's proposal for a revised technical conservation framework regulation. This means that as part of the co- decision process, the European Parliament will shortly commence the main part of its work on this dossier.

The North West Waters Advisory Council represents a wide range of stakeholders (see annex to this letter) many of whom will be directly and profoundly affected by the form that this regulation eventually takes. It is therefore a matter of utmost concern to us that the opportunity provided by this important legislative moment to provide a framework for an effective and flexible technical regime is not lost during the co-decision process.

It is widely accepted that Regulation 850/98 has not provided the basis for an effective set of conservation rules. The highly centralised, one-size-fits-all and prescriptive approach that lies at the heart of 850/98, has proven to be unworkably rigid and inflexible; its requirements difficult to understand and to control.

Our central message to you, at this important legislative juncture, is that although we have concerns about the Commission's proposal, we are completely supportive of its general approach. The goal, which we share, is to effect a decisive shift away from a single set of over-centralised prescriptive rules, towards governance arrangements that allow, over time, for a considerable degree of regional variation and a more results based approach. This is to be achieved using the mechanism expressly provided for in the reformed CFP, for the adoption of joint recommendations by member states acting collaboratively at the regional level.

In principle, detailed technical rules are best designed and applied as close to the fishery concerned as possible, and regionalisation is the vehicle that at present has the most potential to takes us in the direction of this ideal.

It would therefore be a matter of utmost disquiet if the European Parliament, as it legislates on this matter, was to dilute or thwart the scope for regional flexibility that is a central, and for us, the most important part of the proposal. In practical terms this means that the annexes to the regulation should not be weighted with additional detailed centralised requirements by the Parliament, but should allow flexibility and the use of more selective fishing activities, while preserving current activities.

The shift towards a flexible and responsive technical conservation regime contained in this proposal represents a generational opportunity and we fervently hope that the Parliament can help us to achieve that potential.
