objectives

To develop a common comprehension of the fisheries management on the SWW RAC zone in order to contribute to establish long term man**agement plans** for some pilots fisheries for their adoption on regulation by the European Union. To be a proposal and changing force during the Common fisheries policy reform.

why

The SWW RAC could initiate, through a work on two particular stocks [anchovy and southern hake], a dynamics of concerted work between the decision makers [European Commission and national administrations of the Member States], the scientists, and its members [fisheries sector and stakeholders).

Sure that this dynamics will allow going towards a sustainable fishery, the SWW RAC wishes to continue and consolidate this work thanks to the participation of the research institutes and the national administrations.

An Atlas of fisheries to share the knowledge

Professionals, NGO and scientists will work with a common organization of the data to build an interactive and evolutionary cartography, available via the web.

- Halieutic Information system spatialized: technological development ensured by the scientific institutes on the basis of fisheries data collected by the Member States
- Collection of knowledge and practices near the professionals [texts, photographs, videos] at the level of some territories, accessible via web site for a collective appropriation

Management Unites to be doted of a common language


They will be defined by the partners, will be "cartographied" and integrated into the atlas.

Long term management plans to draw a common future

For each management unit, a steering committee made up of scientists, professionals, NGO and representatives of the administrations will write a management proposal fixing objectives at 5 - 10 years.

- Multi-field scientific team [biology, economy] for the creation of indicators or instrument panels
- Contribution of the professionals to put forward rules and measures of management [calendar of activity, gear authorized, plan of exploitation of the resources available,...]
