1	Secretariat to draft a letter regarding the COM explanatory note on the fisheries control regulation revision, taking into account the Europeche open letter on the topic, and include the paed to improve communication and engagement with the NMANAC following
	include the need to improve communication and engagement with the NWWAC, following the COM lack of involvement in the AC March meetings
	Submitted to COM 22/03, the points raised were addressed by the Director-General in the
	Inter-AC meeting on 05 May (report available on the NWWAC website).
2	Secretariat to invite a COM representative to the ExCom meeting on 12 March to discuss
	the explanatory note
	The Secretariat contacted the COM following the meeting and received a negative reply.
3	Secretariat to liaise with the COM on Inter-ACs meetings follow-up and preparation
	An Inter-AC meeting was held on 05 May and the COM presented on the revision of the
	Delegated Act regarding the functioning of the ACs. The COM has asked for submissions
	from the AC on questions/topics that need to be discussed. Members were contacted on
	16 March for input and the Secretariat submitted the suggested NWWAC agenda points on
	26 March. The next Inter-AC meeting will be held on 15 July and the COM will give an
	update on these.
4	ExCom to decide on a reply to the request for feedback on the draft Joint
	Recommendation on Red Seabream prepared by the NWW MSG
	Submitted to the MS on 19/03
5	Members are kindly asked to provide the Secretariat with feedback if and when attending
	ICES meetings.
6	Secretariat to start the planning of the MIAC 2022.
7	Secretariat to send a reminder to members regarding cetaceans bycatch project and
	further work on the topic.
	The secretariat attended both NSAC and PelAC meetings where presentations on this
	project were made. The latest communication from the organisers was received on 18
	June in which the proposed meeting for 01 July was postponed to 09 September due to a
	delay in the EC publishing the new LIFE call. Regarding direct participation in this project it
	was established that this is up to individual member organisations and that the
	ACs/Secretariats will act as distributors of information.

	Organisation is being pursued of a meeting on 29 September – not possible to organize
	this earlier due to COM and MS availability
11	ExCom to approve the list of questions on control issues TCA as distributed by the Control
	Focus Group.
	The list of questions was circulated on Tuesday 09 March.
	An additional query arose from the meeting of WG4 regarding the management of closed
	areas in relation of the TCA.
	Submitted to COM on 18 March.
12	Secretariat to add the draft NWWAC fisheries management chart prepared by the Focus
	Group Brexit on the website for members' review and suggestions.
	Update under FG Brexit
13	Secretariat to add the presentation on restructuring of the AC prepared by the Focus
	Group Brexit on the website. Members are requested to provide feedback prior to the
	ExCom meeting.
	The documents were made available online in the members area directly after the
	meeting. Final proposals will be discussed in the extraordinary GA.
14	Create a task force for the revision of the NWWAC Rules of Procedure and Statutes.
	The Task force was set up consisting of ExCom Chair and Vice-Chairs, and WG Chairs. It met
	5 times and produced the documentation and proposals that will be presented in the
	extraordinary GA.
15	Secretariat to distribute the document on the draft elections' procedures.
	Available online in the Members Area 09/03, full updates are included in the new
	documents that will be presented at the extraordinary GA.
16	Secretariat to send a request for expression of interest/opinions on the possibility of an AC
	performance review (external/internal review).
	This has been put on hold due to the discussions within the Commission regarding
	performance reviews for all ACs. An update from the COM is expected at the next Inter-AC
	on 15 July.
17	Secretariat to launch a written consultation on the functioning of the Members Area.
