Introduction

The North Western Waters Advisory Council (NWWAC) is looking to attract more OIG members to ensure its membership is representative of the full range of relevant stakeholders.

A **60:40** ratio of industry:OIG stakeholders is desired.

Currently, the NWWAC ExCom has 14/15 industry seats filled, but only 3/10 OIG seats.

The NWWAC asked Mindfully Wired Communications to build a **membership drive strategy and materials** to help address this issue by encouraging OIGs to join.

Strategy insights: audiences

Primary audience: NGOs.

- Dissatisfaction with ACs require structural change to see effective participation and meaningful advice.
- Time-poor require evidence that time spent as AC members is impactful.
- Modern communications are visually-led, digital, often for a broad audience.

Secondary audiences: small-scale industry, policy.

- ACs are evolving: the NWWAC has reshaped its Rules of Procedure.






Introduction

Timeline

Mid/late May – Dialogue with interested OIGs. Follow-ups to nonresponsive target OIGs.
