#### Action points from the last meeting

- 1. Secretariat to collect ExCom members written suggestions, add RoP definition of FG, draft amendments and present to ExCom for written approval to submit to GA in September.
- 2. Members to send additional questions for Director Donatella and additional comments on his intervention to the Secretariat for written follow up.
- 3. Secretariat to forward NWWAC outstanding list of topics as raised in the first half of the year, adding question if Celtic Seas fishing opportunities will be discussed, to NWW MSG presidency.
- 4. Secretariat to liaise with performance review team regarding structure of final report.
- 5. Secretariat to add "ecosystem based management" to WG3, adjust in WP FGs in brackets and add WG as originator in NWWAC WP.



#### Action points Working Group 1 – Irish Sea

- 1 Members to send comments on the choke traffic light tool to the Secretariat
- 2 Chair and Secretariat will follow up on haddock de minimis exemption
- 3 Secretariat to draft letter to the Commission and Member States regarding the nonconsideration of the spurdog exemption
- 4 Members to provide the Secretariat with written comments on the UK Discards Plan by the 20 September



#### Action points Working Group 2 – Celtic Sea & West of Scotland

- Members will send input to the consultation to the Secretariat by 20 September, matching the consultation format available online as much as possible. The Secretariat will then check which response format is possible and prepare draft advice based on previous advice and comments received from members.
- The Secretariat will share an updated version of the traffic light choke spreadsheet after the meeting. Members will review it and send comments on West of Scotland stocks to the Secretariat.
- Following up from the hake workshop held in June 2023, the pending issues of catch composition and application of the technical measures regulation across MS will be addressed with EFCA directly.
- The Secretariat will draft letter to the Commission requesting that ICES and STECF are asked to look into mesh sizes and derogations for hake respectively.
- The Secretariat will draft a letter to the Commission on the need of constructive collaboration, specifically on technical matters.
- Following the meeting on 26 September organised by DG MARE on VMEs, the AC will discuss how to follow up on this topic during ExCom meeting on 27 September.



#### Action points Working Group 3 – Channel

- The CNPMEM will get in touch with the Secretariat following the meeting in France on red mullet with an updated proposal.
- Inputs from members on the choke risks will be collated by the Secretariat and reviewed by the Focus Group Landing Obligation to prepare advice. The Secretariat will share an updated version of the spreadsheet with members for further comments if necessary.
- Members to send comments on FMPs to Secretariat by 20 September. One response to be prepared for Seabass/Channel demersal non-quota species/Southern North Sea and eastern Channel mixed flatfish, and one additional each on scallops and whelk.
- 4 Secretariat to draft a letter on impacts of UK HMPAs to the Commission.
