WORKING GROUP 3 (ENGLISH CHANNEL)

The Main Conference Centre – Dublin Castle

Thursday 13th September 2018
15:30 – 17:30

1. Welcome and Introduction

The Chair Pascal Coquet opened the meeting and welcomed the participants.

Apologies were received from Javier Lopez (Oceana) and Alex Kinninmonth (RSPB). The agenda was adopted as drafted.

The Secretariat updated the meeting on the action points from last meeting in July (3rd July 2018):

1. The NWWAC to follow-up the discussions in the Regional Group on King scallops

This will be discussed under agenda item 3.

2. Input on the draft advice ‘Addressing Choke Risk in NWW after exemptions’ for relevant WG3 stocks

Mr Rihan (BIM) presented an overview of the draft advice for the relevant stocks of WG3.

Members raised concerns about the restricted timeline for the procedure in formulating the new JR over the summer. Acknowledging the legitimate concerns raised by STECF, the decision to suppress the combined *de minimis* for pelagic by-catches and for gadoids in the Celtic Sea along with the *de minimis* exemption for whiting in the Irish Sea and restrictions on the survival exemption for plaice in the Celtic Sea, have the potential to create further difficulties in avoiding early closures of important fisheries.

3. Setting the objectives for a Focus Group on King Scallops

Two scientific experts attended the meeting, Dr Ewen Bell (CEFAS) and Dr Erik Foucher (Ifremer). Dr Foucher gave an overview of the scientific work done in France on King scallops (see [website](#)). The discussion following the presentation identified and clarified possible differences in surveys designs across the channel, and reproduction, growth rate and age at maturity between different the scallops beds. The meeting also discussed the potential effects of gear types on catches of small scallops and survivability.

The meeting agreed that further discussion is needed to develop a management plan. Other examples of shared resources between industries could be used as an example, e.g. Pandanus shrimp in US

Members were invited to send their proposals for topics for the Focus Group on Scallops.

ACTION: Members are invited to forward ideas for the Focus Group on Scallops to the Secretariat
