

# NWWAC Horizontal Working Group 11 March 2025

# Paris and online

#### 1. Welcome and introductions

The Chair welcomed all participants, thanked the host CNPMEM and the Secretariat, including Iaria Bellomo attending her first live NWWAC meeting. Apologies were received in advance of the meeting by Gérald Hussenot (Blue Fish) and Geert Meun (VisNed). The agenda was adopted.

## 2. Election of Working Group Chair

The Chair Emiel Brouckaert stated that, having chaired this Working Group since becoming Chair of the Advisory Council over eight years ago, he felt it was time to hand over the reins to someone new. In light of the anticipated appointment of the new NWWAC Chair the following day, he proposed that the new Chair also takes on this position. As a result, he would continue to chair the current meeting, but from the following day, the new Chair would automatically assume the role of Chair of this Working Group, subject to members' approval.

Members approved this proposal.

## 3. "Vision for Agriculture and Food" communication - Ricard Ramon, DG AGRI

The Chair pointed out that on 19 February the European Commission published its Vision for Agriculture and Food by 2040. This Communication sets out a strategy that integrates sustainability, competitiveness, and resilience across the agri-food system. Fishers, like farmers, are portrayed as stewards of nature, essential to both food security and ecosystem resilience. He welcomed Ricard Ramon from DG AGRI who joined the meeting remotely to resent the roadmap, focusing on the main issues.

Ramon outlined the EC vision for the future of agriculture and food, focusing on building a resilient, sustainable, and fair agri-food sector by 2040. It highlights key challenges, including structural issues such as generational renewal, increasingly extreme weather events, and growing geopolitical tensions that impact food security and trade.

The strategy is built on four main principles. It aims to create an attractive and predictable agrifood sector where farmers can thrive, ensuring fair incomes and drawing in future generations. Sustainability is a core objective, ensuring that food production operates within environmental limits. Competitiveness and resilience are also priorities, strengthening the sector against global challenges and external shocks. Finally, fairness is emphasised to create a well-functioning food system that values producers and fosters strong, connected rural and coastal communities.

To achieve these goals, several strategic priorities have been identified. Enhancing the attractiveness of the sector involves improving farmers' income through fairer food chain practices, strengthening the Common Agricultural Policy (CAP) with more targeted and simplified support, and promoting alternative income sources such as the bioeconomy and carbon farming. Ensuring competitiveness and resilience requires reducing reliance on critical imports, strengthening trade fairness, and implementing risk management tools and climate adaptation strategies. Future-proofing the agri-food sector involves supporting sustainability initiatives, strengthening regulations on soil, water, and air quality, and encouraging the use of environmentally friendly technologies. The plan also emphasises valuing food and strengthening rural and coastal communities by promoting fair wages, improving working conditions, enhancing the role of women in farming, and reconnecting food production with regional traditions.

Research, innovation, and digitalisation play a crucial role in enabling this transformation. Investment in digital tools, smart farming technologies, and knowledge-sharing networks is expected to improve efficiency and competitiveness. Strengthening advisory services and promoting innovation are also central to modernising the sector.

Although the presentation primarily focuses on agriculture, its recognition of the importance of coastal areas and rural communities suggests a broader approach that includes fisheries. Ensuring fair working conditions, sustainable resource management, and resilient food supply chains applies to both agriculture and fisheries, reinforcing the need for an integrated food policy.



The EC calls for continued stakeholder engagement to refine and implement these strategies, with a key event scheduled for 8 May to further develop the vision. The overall aim is to transform Europe's food system in a way that balances economic viability, environmental responsibility, and social equity, ensuring a thriving and sustainable sector for future generations.

The **Chair** thanked Ramon for his detailed presentation and opened the floor to questions.

Alexandra Philippe felt that a lot of measures in this vision could be applied to fisheries and aquaculture. She recalled that Commissioner Kadis mentioned that this vision included fisheries and aquaculture, but following this presentation felt that these have not been included. In her opinion this is a missed opportunity, as there is a strong link between food and fisheries. Despite the development of the Ocean Pact, there is yet no clear link with seafood. She referred to the annual food dialogue and promotion of food supply chain and other measures that concern trade measures where fisheries should be involved. She underlined that what has been proposed for the agriculture sector can be interesting also for the fisheries sector. She suggested that the AC should develop advice asking the Commission to not miss the next opportunity to create a link between sustainable food systems and fisheries.

**Patrick Murphy** commented that a level playing field is needed for food producers. He felt that fisheries seem not to have the same importance as agriculture. Referring to carbon credits given to agriculture producers for reducing their carbon footprint or improving their production methods he wondered if fishing vessels which reduce their carbon footprint would be able to access the same benefits.

**The Chair** agreed with the proposal to produce advice on this topic as he felt that the main actions of the EC Communication seem fitting for fisheries. He enquired if Ramon saw any opportunity for the fishing sector to get more involved in the discussion and road map.

**Franck Le Barzic** commented that fisheries have their own particularities and cannot always be put in the same line with agriculture (i.e. geographic indications). He felt it was important to make sure that imports entering the EU market should also follow the same rules.

**Dimitri Rogoff** felt that agriculture and fisheries should not be addressed in the same vision as there are lot of differences. He explained that as there are a variety of marine proteins, and that it is important to inform consumers regarding the differences compared to agricultural products. He also commented that communication on traceability should be improved, for instance in restaurants.

**Ramon** replied that the Commission wants to be honest on what is put forward and not to create false expectations regarding ideas from the fisheries sector. He explained that this vision addresses agriculture and food. A specific vision for fisheries should be put in place. He felt it was useful to receive comments and criticism in order to identify with DG MARE on how to better articulate fisheries in the dialogue. He informed participants of an event taking place on 08 May which will also address food systems and could include discussions on fisheries.



Regarding decarbonisation Ramon felt that awareness was needed of the differences between fisheries and agriculture, as agriculture captures carbon, that is why there are support mechanisms for farmers. On imports and strategic autonomy, he felt that this was also important for fisheries as there is a need for greater independence. Ramon appreciated the discussion and offered to continue the dialogue in the future.

The Chair thanked Ramon for his participation and added that the AC would work further on this topic.

# 4. CFP evaluation state of play - discussion of NWWAC advice

On 27 January the European Commission opened a public consultation to gather evidence, insights, concerns, ideas, and feedback on the effectiveness of the common fisheries policy (CFP) regulation from a range of stakeholder. Deadline for this exercise is 21 April, and the Secretariat has drafted a first response based on previous consensus advice from this AC. As this work falls under the remit of the Focus Group CFP, the Chair handed over proceedings to the FG Chair Alexandra Philippe.

**Philippe** recalled that the Secretariat circulated the very first draft advice ahead of this meeting. This was pulled together from previous NWWAC consensus advice fitting the questions in the Commission's questionnaire. She opened the floor for questions and a first exchange of views on the topic.

**Jean Marie Robert** expressed his satisfaction regarding the comprehensiveness of the document and felt that all elements were well developed. He suggested the need to identify priority issues as the document is very long.

**Philippe** agreed pointing out that NWWAC advice usually starts with a section on key points, which will be replicated for this advice.

**Manu Kelberine** felt that there was a problem related to the methodology and referred to the consultation on the landing obligation. He added that this should be included in the main points.

**Le Barzic** agreed with the proposal to identify key priorities and queried the structure of the draft advice. **The Secretariat** explained that the response was drafted in the same format as the questionnaire provided by the Commission in the online public consultation.

**Dominic Rihan** expressed his view that the questionnaire was not a valuable use of time, as the Commission will probably use AI to report answers. He felt the AC should concentrate on what is important for its members and focus on a few priorities as otherwise everybody will have their own comments.



**Pauline Stephan** suggested to provide practical examples to support certain facts and make the response more impactful.

Following a brief discussion **Philippe** suggested that the advice could include individual responses to each question. In addition, the AC could ask members to submit 3-5 topics for prioritisation, for example regionalisation, Brexit, role of the AC, which could be addressed in a strategic two-page preface to the questionnaire response. For the latter it would be useful to add practical examples. Finally, for questions where members do not agree, it could be noted that the AC does not have no position.

**ACTION**: Secretariat to circulate draft CFP response and ask for additional input on strategic topics. Next meeting of FG CFP to be organised for end of March to continue advice drafting.

### 5. MIAC/MIACO follow up

The Chair explained that this year's MIAC and MIACO meetings covered numerous important aspects which would benefit from a closer evaluation by the members of this AC. While the report from the MIAC meeting has already been circulated by the Secretariat and is also available online in the Members Area, the MIACO report is not yet available. A discussion followed on key aspects.

 Stability and consistency of advice, multi-annual advice discussion in MIRIA subgroup after March ACOM

The NWWAC asked what efforts ICES is currently making to improve the stability of scientific advice and incorporate innovative methodologies, such as genetics to strengthen data on poorly documented stocks and can aspects other than management be considered obtained to obtain more stability. At the MIAC meeting, ICES responded that during MIRIA a mechanism was discussed to get in touch with stakeholders sooner. Regarding the stability clause for category 1 and 2 stocks, these are mainly based on available MSY data, and it was felt that there is no logic to have a stability clause. In addition, in ICES' view stability is also the responsibility of managers. It was also noted the WKLIFE is working on improving data limited methods which are mainly focused on the category 5 and 6 stocks for which it is currently very difficult to develop proper advice.

**Rihan** felt that it was important for this AC to keep pressure on ICES regarding their work on cat. 5 and 6 stocks as what is being produced now is not proper advice.

**Le Barzic** recalled that when there is no sufficient data, it woud be better not to move the stock from different categories. For example, he felt that the transfer of category for pollock was not beneficial.



**Olivier Lepretre** commented that the ICES Methodology should be reconsidered, involve more fishers to be more consistent with the reality on the ground and include more accurate data.

- (Fishers) data inclusion in assessment of during data compilation workshops
  - Several WG addressing this issue and an example of ICES following up is the results of WKIRISH working on  $F_{\rm eco}$
  - Stakeholders have the possibility to contribute via the Data Compilation Workshops for benchmarks as pointed out in WKAFPA.
  - Missing data overview on the ICES website: "issue list" is available and stakeholders have the possibility to add comments which are only seen by the Stock Assessor.

#### • ICES mixed stock guidelines

- At MIACO, the Chair request input for ACOM discussions in March.
- Meeting reactions: mixed stocks advice should start with mixed stocks assessments; mixed stocks management should be considered by managers and not based on ICED headline advice; ICES advice sheets useful, managers should consider more than headline advice; mixed stocks fished by mixed type of vessels/gears.

## Inter-AC Brexit Forum (Chair)

The Inter-AC Brexit Forum was established between PelAC, NWWAC, NSAC, LDAC and CCRUP. The first meeting in Year 20 was held last 4 February and chaired by the PelAC. The next meeting will be organised by the LDAC, no date available yet.

Topics at SCF: King Scallops multi-year strategy; Celtic Sea: FMP; Roadmaps for certain stocks, incl. sole 7h,j,k; rockall cod, plaice 7f,g; Spurdog; Benchmark on pollack; MPAs; Seabass; Technical measures; TCA Review 2026.

**Rihan** noted that the REM issue was missing from the list. He also expressed his disappointment regarding the lack of updates on the TCA review 2026.

**Lepretre** highlighted that it would be important for future negotiations to be informed and to know how to better intervene and be prepared.

# • CFP (Alexandra Philippe)

Next steps on the NWWAC advice on CFP evaluation have been agreed under point 4 of the agenda.

#### Landing Obligation (Chair)

The last meeting was held on 22 November 2024. The NWWAC provided advice addressing choke risks in NWW after exemptions published on 13 January 2025.

During the meeting, the Secretariat has received an email from the Commission with some updates on LO study, which should be published by the end of the month. "The exercise is close to end; the final report of the study is expected to be submitted by the contractors still this month (by the end of March 2025) and we will publish it as soon as the administrative steps of



the contract would be finalized by CINEA colleagues (namely, approval of the final deliverable and payment), hopefully between April and May 2025."
