# Action points from the last meeting

- 2. The ExCom approved the changes proposed in the text to be shared with the PelAC ExCom for approval.
- Chair to take option A from the meeting policy proposal to the General Assembly for approval. 3.
- 4. ExCom approved the overview on year 17 accounts to be presented to the General Assembly.
- 5. Information on the EFCA Advisory Board should be shared with all ExCom members to trigger expressions of interest to attend on behalf of the AC.
- 6. Secretariat to request input from members on items to suggest for the Inter-AC Brexit Forum agenda. Secretariat to launch written consultation of NWWAC members for input to MIAC and MIACO agendas. 8. Secretariat to get information on Barrie Deas retirement date and prepare an official message from the
- ExCom thanking him for the contribution to the work of the AC.

### Action points Working Group 1 – Irish Sea

- 1 Secretariat to check with ICES if any research (ongoing and/or planned) on cumulative effects of ORE developments is available. If not, recommendations should be developed by the AC requesting that this topic is investigated.
- 2 NWWAC to recommend the COM that ICES is requested to include climate change impacts on cod spawning – specifically increasing seawater temperature – into the stock assessment.
- 3 Comments made on exemptions to the Landing Obligation should be taken into account in the preparation of the AC advice on the Discard Plan 2024 by the Focus Group Landing Obligation.
- Follow up on recommendations included in the Fishing Opportunities 2023 advice in relation 4 to the Irish Sea and consider new issue raised on pollack assessment (mismatch between landing and catch data).



### Action points Working Group 2 – Celtic Sea & West of Scotland

- Continue NWWAC work on ORE developments jointly with other Advisory Councils if possible
- Working Group members are invited to send their comments on exemptions to the 2 Landing Obligation to feed the preparation of the advice on the Discard Plan 2024 being prepared by the Focus Group Landing Obligation. In particular, members are invited to reflect on measures introduced which resulted in an increase in selectivity and in survivability.



### Action points Working Group 3 – Channel

- CNPMEM to share proposal for advice on red mullet with the Secretariat which will distribute to Working Group 3 for review and then to ExCom for approval.
- 2 Secretariat to inform WG3 members on Member States Group's feedback on whelk advice
- 3 The advice on a joint recommendation for managing the scallop fishing in the Channel is put on hold at the moment. Irish and French members will liaise regarding the use of 97mm rings and come back to the Secretariat once updates are available.
- 4 Discuss the complaint from EAA and IFSUA regarding production of advice on seabass at ExCom. Secretariat to draft procedure to clarify how lack of consensus should be addressed when an advice is prepared.
- 5 Follow developments on designation of MPAs on both EU and UK sides and combine this work with the review of the CFP package.
- Working Group members are invited to send their comments on exemptions to the Landing 6 Obligation to feed the preparation of the advice on the Discard Plan 2024 being prepared by the Focus Group Landing Obligation.
