


Action points from the last meeting

8. UK MPA consultation

- Management of English offshore marine protected areas consultation deadline 01 September
- Stakeholder meeting scheduled for 15 July
 - Stage 3 Formal Consultation of proposed management measures in 42 MPAs
 - prohibitions of fishing using bottom towed gear in specified areas in 31 MPAs;
 - prohibition of fishing using bottom towed gears and prohibitions on fishing using static gears (traps and/or bottom set nets and lines) in specified areas in four MPAs;
 - prohibition of fishing using traps in a specified area of one MPA;
 - prohibition of fishing using bottom towed gear and prohibition of the removal of spiny lobster, also known as crawfish (Palinurus elephas) in a specified area of one MPA;
 - minor changes to existing bottom towed gear prohibitions in 5 MPAs to reflect the most up to date approach, habitat location and depth information.

Proposal of a NWWAC WhatsApp Community

Objective: Improve internal communication within the NWWAC

Current Situation:

- Secretariat shares the NWWAC work via email
- High email volume can lead to key messages being missed
- Increased need for clear, accessible communication



Proposed Solution:

- Launch a WhatsApp Community for NWWAC
- The Community will be internally divided into subgroups (ExCom, WGs, FGs)

Key Features & Benefits:

- Voluntary participation
- Not a replacement for formal email communications
- One-way communication (members cannot reply)
- Designed for quick, informal updates including: Deadlines; Meeting reminders; News from the EC: Press releases; NWWAC Social media content
- Already used effectively by many organisations
- Helps members stay connected and informed
