Action points from the last meeting

- 1. Members to submit additional questions for DG MARE to the Secretariat for written response.
- 2. AC to follow up on necessary responses to UK FMPs consultation.
- 3. NWWAC to put forward to the Commission ideas on changes in management principles, for example spurdog.
- 4. FG Spatial Dimension to address socio-economic assessment of developments within MSP.
- 5. AC needs to clarify that it was not consulted as part of the JR VME. Identify FG to follow up on discussion points re VME to take forward work.
- 6. Vice-Chair elections are postponed until March 2025.
- 7. Secretariat to initiate next steps in the procedure for the appointment of a new AC Chair.
- 8. AC needs to make an effort in addressing conflict within the AC to reestablish trust and cohesion.
- 9. Members to review Work Programme and ensure that proper action is taken on the items identified.
- 10. Members to revert to either the Secretariat or Stephan directly to establish if their country is interested in developing the ACFishMap in other ACs.



Action points Working Group 1 – Irish Sea

Follow up with BIM to keep the AC informed on the upcoming gear trials which will take place during spring/summer this year.

WG to develop query to the Commission regarding the monetisation of carbon credits for the fishing industry.



Action points Working Group 2 – Celtic Sea & West of Scotland

- Further engage with AZTI following the presentation and dissemination of the Northern Hake Stock dynamic
- Declining SSBs while MSY-fished: members agreed to further dig in regarding the causes of the bad recruitments that several stocks are facing, leading to decreasing SSBs for several important stocks. Though not very specific at this moment, the idea would be to further look at inter-specific predation (boarfish, bluefin tuna..), intra-specific mechanisms (cannibalism), and should include analysis regarding the data collection for food stomachs analysis, that we could encourage to be funded if necessary. Asking the EC to organize a specific request to ICES could be developed.
- Include a presentation of the Nephrops Porcupine Survey by BIM during WG2 meeting in July.



Action points Working Group 3 – Channel

- 1. Secretariat to contact ICES to present the seabass benchmark results to the FG seabass and discussion on the implications for advice and future management of stocks.
- 2. Secretariat to organise next meeting of the FG Scallop to discuss technical measures
- 3. Working Group to follow the Member States Group's discussions on lemon sole and red mullet
- 4. Working Group to follow the results of the Benchmark on flatfish in the Eastern Channel and the related advice



Action points Horizontal Working Group

- 1. NWWAC to develop advice on the "Vision for Agriculture and Food" roadmap.
- 2. Secretariat to circulate draft CFP response and ask for additional input on strategic topics. Next meeting of FG CFP to be organised for end of March to continue advice drafting.
- 3. Secretariat to circulate invitation for ICES WGENGAGE.
- 4. Secretariat to share ICES documentation from MIAC/MIACO in NWWAC Members Area. AC to follow up in HWG topics from MIAC and MIACO possibly for July meetings.
- 5. Secretariat to contact LDAC regarding next meeting of Inter-AC Brexit Forum and emphasise the importance of including detailed update on TCA review 2026. Possibility to formulate request to Commission regarding increased AC involvement on this topic.



Action points Horizontal Working Group

- 6. FG Climate to meet and prepare advice on Energy Transition Partnership.
- 7. Secretariat to contact UK Seabass group again for AC inclusion in work. Secretariat to organise next meeting once benchmark results are available.
- 8. Proposal to the joint FG Social Aspects to include in ToR a case study of area 7d.





8 Election of NWWAC ExCom Vice Chairs

The Vice Chairperson(s) of the Executive Committee

- 42. Three members, two nominated from within the industry college and one nominated from within the OIG college, shall be appointed by the members of the Executive Committee for a (renewable) term of three years. The Vice-Chairperson(s) shall be a member(s) of the Executive Committee and shall have a vote.
- 43. Nominations must be made by Executive Committee members during the first meeting of the newly elected Executive Committee and seconded by another Executive Committee member.
- 44. Members of the Executive Committee will vote for Vice-chairpersons in an open ballot.
- 45. If the same amount of votes is received by two or more candidates, the Secretariat shall initiate a secret second ballot via electronic procedure within one week of the first ballot held.
 - Procedure based on AC Chair being a member of the industry college
 - Proposal to amend procedure and elect three Vice-Chairs from industry college as Chair is now from OIG college
