Stability and consistency of advice

NWWAC at MIAC: What efforts is ICES currently making to improve the stability of scientific advice and incorporate innovative methodologies (such as genetics) to strengthen data on poorly documented stocks? Can aspects other than management be considered to obtain more stability?

- discussion with managers (MIRIA) on mechanism to get in touch with stakeholders sooner
- stability clause for category 3 stocks, because data limited; cat 1. & 2 stocks MSY-based advice, not logic to have a stability clause
- MIRIA subgroup to discuss provision of multi-annual advice
- consideration of stability is the responsibility of managers, also how to use advice (decision to look beyond headline advice)
- WKLIFE working on improving data limited methods





(Fishers) data inclusion in assessments or during data compilation workshops

- several Working Groups addressing this issue and an example of ICES following up is the result of WKIRISH, working on FECO.
- possibility to contribute via the Data Compilation Workshops for benchmarks as pointed out in WKAFPA
- missing data overview on the ICES website: 'Issue List' is available and stakeholders have the possibility to
- add comments which are only seen by the Stock Assessor.




Mixed Stocks Guidelines

- ICES Presentation
- At MIACO request input for ACOM discussions in March
- Meeting reactions:
 - Mixed stocks advice should start with mixed stocks assessments
 - Mixed stocks management should be considered by managers and not based on ICES headline advice
 - (ICES advice sheets useful, managers should consider more than headline advice)
 - Mixed stocks fished by mixed type of vessels / gears




ICES Overviews - background


 The purpose of the Overviews is to provide the context for EBM of human activities affecting the marine environment and marine living resources
