- 9 Working Groups to add standing agenda item on small-scale fisheries.












Approval of updates to reimbursement rules

- Max. travel expenses: change from \in 800 to \in 600 (\in 800 remaining in exceptional circumstances)
- Car rental will not be reimbursed.
- Hotel allowance increase from €100 to €120.
- Daily allowance increase from €92 to €100.
- Where the meeting duration is less than a full day, half the daily rate (\in 50) is applicable. If food is provided at the place of meeting, the following will be deducted: \in 25 per lunch, \in 50 per dinner.
- Travel time to and from the meeting is not covered by the NWWAC but should be covered by each organisation.
- Additional sentence under insurance: The NWWAC shall not be liable for any cancellation fees incurred by member organisations' representatives due to circumstances outside the NWWAC's control.
